

## Foreign national Individual Taxpayer Identification Number guidelines

This program is designed for persons residing in the U.S., and intending to remain in the U.S., who cannot produce a current visa or green card but can demonstrate payment of federal taxes via their Individual Taxpayer Identification Number (ITIN) – a Social Security-type number that will start with a "9." Also eligible for the ITIN program are applicants that hold an employment authorization document (EAD) with a category of A10, C08, C10, C14, or C33. This program is assessed on a case-by-case basis and is subject to change or cancellation at any time without prior notice.

## **Underwriting requirements**

**Proof of residency status:** For ITIN holders, we will need the CP565 form or Social Security card. For EAD holders with one of the eligible categories noted above, we will need a copy of that card.

**IRS Form 4506-C:** This program requires, at a minimum, tax returns from the two immediately prior, consecutive Federal tax filing years available at the time of the application. The prefilled 4506-C, available on the Transamerica agent portal, must be used. Financial justification of the insurance need will be based on verifiable income and in accordance with Transamerica's financial underwriting guidelines.

**U.S. residence:** Has resided continuously in the U.S. for at least one year, and up to a minimum of two years depending on country of origin, and present to the date of the application and policy delivery. At all times, the policy owner must maintain a U.S. mailing address and continue to pay all premiums through a U.S. financial institution.

Country of citizenship: Include the applicant's country of citizenship on the application.

Medical underwriting: Applicants may require a paramed exam (or vitals) and labs.
