#### IFC & NFPA 101 Mandates

Did you know that you are required, by Code, to annually inspect and maintain firestop systems?



Both the International Fire Code<sup>®</sup> and NFPA 101 Life Safety Code<sup>®</sup> mandate inspection and maintenance of firestop systems. Any time a fire protection feature is incorporated into a building, it must be continually maintained to ensure compliance. And when it comes to structured cabling, the constant moves, adds, and changes can wreak havoc on fire and smoke barrier integrity, requiring significant time and resources to be devoted to remediation and maintenance.
