*Under this co-pay assistance program, most eligible patients pay a \$5.00 co-pay for each prescription of Tyvaso or Tyvaso DPI.



Eligible patients will pay as little as \$5.00 for each prescription of Tyvaso or Tyvaso DPI up to \$8,000.00 per calendar year. Patients transitioning from one Tyvaso product (nebulized/DPI) to another may be eligible for an additional \$4,000.00 during the calendar year in which the transition occurs. A valid Prescriber ID# is required on the prescription.

Pharmacist instructions for a patient with an Eligible Third Party: Submit the claim to the primary Third Party Payer first, then submit the balance due to CHANGE HEALTHCARE as a Secondary Payer COB (coordination of benefits) with patient responsibility amount and a valid Other Coverage Code, (e.g. 8). The patient is responsible for the first \$5.00 and reimbursement will be received from CHANGE HEALTHCARE.

Pharmacist instructions for a cash paying patient: Submit this claim to CHANGE HEALTHCARE. A valid Other Coverage Code (e.g. 1) is required. The patient is responsible for the first \$5.00 and reimbursement will be received from CHANGE HEALTHCARE.

If your co-payment is more than \$5.00, the Tyvaso and Tyvaso DPI Co-pay Assistance Program will automatically pay the difference up to the annual maximum benefit, directly to your pharmacy.

- This program is only valid for the cost of the drug (Tyvaso or Tyvaso DPI) and not applicable to any related supplies or other medical expenses associated with administering the product.
- The patient will be responsible for any remaining balance that is not covered by their initial \$5.00 co-pay and the annual maximum program benefit.
- The annual maximum benefit reimbursable to a pharmacy is \$8,000.00 for Tyvaso/Tyvaso DPI during a calendar year.
- The pharmacy may be reimbursed up to an additional \$4,000.00 for patients transitioning from one Tyvaso product (nebulized/DPI) to another within the same calendar year due to the change from medical to pharmacy benefit or vice versa. The increased annual limit applies only within the year of transition.
 - Example: Patient transitioning from Tyvaso to Tyvaso DPI, the pharmacy may be reimbursed an additional \$4,000.00 during the calendar year in which the transition occurs.

By using the Tyvaso and Tyvaso DPI Co-Pay Assistance Program you acknowledge that you currently meet the eligibility criteria and will comply with the terms and conditions described below:

- The Program is valid only for patients with commercial (also known as private) insurance who are taking the medication for an FDA approved indication.
- Patients using Medicare, Medicaid, or any other state or federal government program to pay for their medications are not eligible. Patients who start utilizing government coverage during the term of the Program will no longer be eligible.
- Eligible patients must be a resident of the US or Puerto Rico.
- The Program is subject to additional state law restrictions. Patients residing in select states may not be eligible for the Program.
- This Program is only valid for cost of the drug and not applicable to any related supplies or other medical expenses associated with administering the product.
- This Program is not conditioned on any past, present or future purchase, including refills.
- Void where prohibited, taxed or restricted by law.
