The responsible sourcing of conflict minerals is imperative to a successful value chain that complies with regulatory concerns and the social and governance priorities of organizations and their stakeholders. However, engaging suppliers, tracking smelters, refiners, and other entities, and completing due diligence activities to mitigate risks and ensure compliance requires vigilance and expertise that many organizations are not equipped to provide.

Finding a Solution: Engaging Suppliers, Centralizing Data, and Establishing Risk Standards

Navigating Supplier Risk Challenges

Running a decentralized business structure where each of its 200 businesses operates autonomously, the multinational electronics producer was challenged with standardizing supplier risk criteria, consolidating supplier communication efforts, and providing widespread visibility into supplier code of conduct, compliance, and risks.

The organization needed a way to collect supplier data to meet annual compliance regulations, such as the U.S. SEC Conflict Minerals Disclosure, which supports supplier outreach on smelters and refiners, automates responses using the standard Conflict Minerals Reporting Template (CMRT), and performs risk assessments on those responses to approve or reject them for continued use.



Results: Increased Conflict Minerals Compliance and Due Diligence

Following the multifaceted solution implementation, the organization significantly improved its supplier risk management and compliance program.

- Global coordination across 9 business units and over 28K suppliers.
- Heightened due diligence on 4 global refiners of concern.
- Increased efficiency in compliance with US SEC Conflict Minerals Disclosure by 70-80%.

Based on the success of the project, the organization is expanding its work with both Benchmark Gensuite and Levin Sources to comply with the German Supply Chain Act:
