We prefer electronic invoices. Please always include Eficode's contact person in the invoice. Also, make sure you are invoicing the right company in our group. Billing address should be visible on the invoice.

We only accept invoices with payment terms of 30 days or more, unless agreed otherwise.

Please note that we do not accept invoices to our street address, or any other way that is not included in these instructions.

**When sending PDF invoices, we kindly ask you to consider the following:**

- PDF invoices are to be sent as email attachments.
- Only one invoice per file. The file should include the invoice with all its pages and attachments.
- Multiple invoice files can be sent in one email. In this case all invoice files must be named separately.
- The maximum size for an email is 10 MB.
- The file names can only include regular characters: a–z, A–Z, 0–9.
- PDF files must be real PDF documents (not scanned to PDF). PDF documents must be version 1.3 or newer.
- PDF files cannot be locked, encrypted or password protected.
