AMG Vanadium LLC is a wholly owned subsidiary of AMG Advanced Metallurgical Group N.V., a global leader in the production of highly engineered specialty metal products and advanced vacuum furnace systems. Located in Cambridge, Ohio, AMG Vanadium specializes in the environmentally beneficial conversion of oil refinery and power plant waste products into specialty metals used by global steel producers in automotive, energy transmission and infrastructure applications. By using materials that would otherwise be discarded as waste, AMG Vanadium encourages environmental stewardship, energy conservation and resource recovery, making it the environmental leader in this global industry.

### Business Need

AMG Vanadium needed a new facility to respond to growing demand from the global refining and steel industries. The new Zanesville, Ohio, facility will be similar to AMG's Cambridge plant and include a roasting and ferro alloy production facility.
