The opioid epidemic is an ongoing public health crisis that continues to impact families and communities across the country. Job losses and social isolation caused by the COVID-19 pandemic have further exacerbated this crisis.

State and local decision makers now have a unique opportunity to improve their response, with new funding available from the federal government and from opioid settlement funds.

Thankfully, best practices are emerging to guide implementation and ensure funding is spent effectively. Best practices include:

- Funding warm hand-off programs and recovery services: the settlement recommends expanding services available in the recovery journey, facilitating access to holistic supports
- Supporting data collection and research on availability and quality of programs, and services, including collecting data in smaller populations, by creating equal partnerships with communities

Design effective interventions

- Care in the clinical setting alone is not sufficient to address prevention, treatment, and recovery. Individuals with substance use disorders need clear access to **comprehensive services** including employment, childcare, and housing.

- Timely data is essential to monitor emerging trends, inform decision-making, and evaluate impact of investments and services provided.
