
### Success stories

#### Meeting locally to hear global perspectives

Underwriters Laboratories hosted meetings focused on UL 2272, the Standard for Safety for Electrical Systems for Personal E-Mobility Devices, in collaboration with the Beijing Research Institute of Automation for Machinery Industry Co., Ltd., which is a participant on the UL 2272 Standard Technical Panel (STP).

Through an MOU between UL and Standardization Administration of China (SAC)/Technical Committee (TC) 159, China's national hoverboard working group, the groups are working together to develop a harmonized standard for hoverboards. It is the first project between China and the United States that is endorsed by the SAC and the American National Standards Institute (ANSI). The harmonization will reduce technical differences and facilitate trade between China and the United States.

In addition, the UL Standards team hosted a meeting at UL's offices in Japan in December 2019, at which representatives from China, Japan, Singapore and South Korea received an update from the team regarding development of UL 4600, the Standard for Safety for the Evaluation of Autonomous Products, to provide expanded opportunity for local engagement. The meeting included a presentation on UL Standards development process an overview of the Standard, its structure, and the factors and systems within its scope. Group discussion centered on addressing questions about the development and content of the Standard and how it will be applied.



# New Cooperation agreements signed in 2019



Underwriters Laboratories signed several agreements in 2019 to further our cooperation with national standards bodies, regional standards bodies and relevant standards organizations. These agreements formalize our partnerships and establish key objectives and strategies, including knowledge sharing, participation on STPs and other mutually beneficial steps to drive increased relevance and influence of standards throughout the world. # Highlights

#### African Organization for Standardization (ARSO)

The Underwriters Laboratories Standards team signed an agreement with ARSO on Sept. 18, 2019, in Cape Town, South Africa, strengthening its relationship and agreement to work together. With this agreement, UL Standards shared access to 37 ARSO member countries.

#### **Confederation of Indian Industry (CII-IQ)**

Underwriters Laboratories signed an MOU with CII-IQ on Sept. 25, 2019, in New Delhi, India. The signing of the document signifies the working relationship between UL and CII-IQ, with the shared goal of evolving the capacity of the Indian standards ecosystem and helping industrial bodies develop region specific standards. Expanding CII-IQ's safety mission through standards, the MOU allows us to work together to identify areas that need development of sectoral standards, provide awareness and training, and enable adoption of UL Standards as relevant to India.

#### **Enterprise Singapore (ESG)**

During the 2019 Pacific Area Standards Congress (PASC) meeting in Wellington, New Zealand, Underwriters Laboratories signed a collaboration and license agreement with ESG, the national standards body of Singapore. The focus will be on standards collaboration in emerging areas such as additive manufacturing and smart cities.

# Standardization Administration of China (SAC)

James M. Shannon, chairman of Underwriters Laboratories, and Cui Gang, general director of Standards Innovation Management, Standardization Administration of the People's Republic of China (SAC), signed an MOU at the Shanghai International Convention Center during the IEC General Meeting. SAC is authorized by the State Council to undertake unified management, supervision and overall coordination of standardization work in China. It represents China at the International Organization for Standardization (ISO), International Electrotechnical Commission (IEC), and other international and regional standard organizations, and is responsible for organizing the activities of the Chinese National Committee. This agreement is significant as it positions Underwriters Laboratories and SAC to work together to promote safety through standards.


### UL 2900-2-1, the Standard for Safety for Software Cybersecurity for Network-Connectable Products, Part 2-1: Particular Requirements for Network Connectable Components of Healthcare and Wellness Systems

With the increasing threat of cyberattacks affecting safety-critical products and service infrastructure, the UL 2900 Series of Standards aims to provide a foundational set of requirements that manufacturers of network connectable products can pursue to establish a baseline of protection against known vulnerabilities and a foundational set of security risk controls to consider relative to their existing overall product risk assessments.

UL 2900-2-1 describes the method by which the security risk controls of healthcare system components shall be evaluated and tested for known vulnerabilities, software weaknesses and malware, while also establishing a foundational set of verification activities intended to reduce the likelihood of exploitable weaknesses that could be vectors of zero-day vulnerabilities that may affect the component. UL 2900-2-1 is a recognized Standard of the United States Food and Drug Administration for medical devices for software/informatics. Health Canada recommends the use of UL 2900-2-1 for guidance on cybersecurity testing.

#### UL 5500, the Standard for Safety for Remote Software Updates

This first edition Standard covers remote software updates taking into account the manufacturer's recommended process. It is limited to software elements having an influence on safety and on compliance with the particular end-product safety Standard. In addition, this Standard covers hardware compatibility necessary for safety of the "remote" aspects of the software update.



#### BSN-UL Standards Workshop in Jakarta, Indonesia

Underwriters Laboratories and BSN, the national standards body of Indonesia, organized a joint standards workshop and seminar in Jakarta in July 2019 to increase visibility of UL Standards and promote collaboration between the two organizations. Under the theme "BSN and UL Safety Standards supporting Indonesian National and Regional Priorities," the event was attended by 110 people and focused on Standards for fire protection and battery safety by raising awareness of the importance of safety Standards as the underlying building blocks for Indonesia.

#### China

Underwriters Laboratories has been involved in several events to build relationships and partnerships in China. A workshop and roundtable was held in Dongguan to meet with local stakeholders and shared knowledge with one another on standards. An agreement with the Dongguan Humen Information Wire & Cable Association gave the team the opportunity to hold local STP working groups and to engage UL standards participation at the local level. It is important to receive input on the local demands of UL standards and to work with organizations to receive input for international consideration.

Underwriters Laboratories was also invited as a key partner at the Qingdao International Forum. After years of partnerships, our cooperation was expanded to establish a UL STP working group with the Qingdao Standard Institute to work on standards in the household appliance category. This working group supports local stakeholders to take part in UL's standards development and other local initiatives. A significant MOU signing occurred with the Standardization Administration of the People's Republic of China (SAC), the national standards body of China. This enables both organizations to work together at the national level and expand our mission.

#### **Interaction with the BIS**

The BIS office hosted a workshop on the standards development process in the U.S. and other countries in September 2019 for key BIS personnel. Phil Piqueira, Underwriters Laboratories vice president, Global Standards, and Sonya Bird, Underwriters Laboratories director of International Standards, presented on the American standardization system and the UL Standards team's development process. This marked the first time an external standards development organization conducted a standardization process workshop at the BIS office.

#### **GSO World Standards Week**

The Gulf Standardization Organization (GSO) in cooperation with the General Secretariat of the Gulf Cooperation Council (GCC) organized GCC Standardization Week 2019, taking place in October 2019 in Riyadh, Saudi Arabia. Presentation topics included Gulf standards, facilitating trade exchange as well as the role of media in disseminating standardization awareness. Underwriters Laboratories presented to showcase its services in the region and offer different solutions for the local market. The audience showed particular interest for the fast track solutions that Underwriters Laboratories adopts for developing standards in a short period of time as a quick response to certain market conditions/incidents.



#### India: Special National Standards Conclave

Underwriters Laboratories was a partner in the Special National Standards Conclave held in February 2019 and attended by 300 representatives of regulatory agencies, industry associations, and international standardization and conformity assessment organizations. UL Standards staff presented on the strategy for harmonizing standards with globally published standards, a strategy to dominate international standards in critical sectors for India and acceptability of industry driven standards.

# India: UL-CII workshop of standards development capacity building

This workshop was inaugurated by BIS, Underwriters Laboratories and CII in September 2019. Over 35 participants representing more than 25 organizations attended the workshop and learned more about the standards development process.

#### ISO Week in Cape Town 2019

Underwriters Laboratories participated in the 42nd ISO General Assembly 2019 and the 53rd ISO Committee on Developing Countries Matters (DEVCO) meeting in Cape Town, South Africa, in September 2019. During the week, the UL Standards team signed four collaboration and license agreements with partner organizations.

#### **PASC 2019**


Underwriters Laboratories participated in the 42nd Pacific Area Standards Congress (PASC) Annual General Meeting (AGM) held in Wellington, New Zealand, from April 8-11, 2019. The delegation met with a total of 13 Asia Pacific countries during the event. Among the highlights was the signing of a collaboration agreement between Underwriters Laboratories and Enterprise Singapore, in which both parties committed to the development and promotion of standards to help enable the safe use of emerging technologies, such as additive manufacturing, cybersecurity, autonomous products and more. The Underwriters Laboratories team took this opportunity to chart action plans with existing MOU partners from Viet Nam and Indonesia to bolster fire safety and battery safety systems in these countries through UL Standards. The delegation also discussed potential areas of collaboration with the key national standards bodies in the region from China, India, Japan, Australia, Korea and the Philippines.

In addition, the Underwriters Laboratories team met with key IEC and ISO leaders, including James M. Shannon in his role as president of IEC, and John Walter, president of ISO.


#### Latin America/Mexico

The "Building a Safe Infrastructure for Electric Vehicles Technical Workshop," co-hosted by Underwriters Laboratories, the CARICOM Regional Organization for Standards and Quality (CROSQ) and the Trinidad & Tobago Bureau of Standards (TTBS) took place in Trinidad and Tobago on Oct. 1, 2019. Participants included a wide variety of stakeholders from across Trinidad and Tobago, including: regulators, private entities, infrastructure owners, academics and other subject matter experts.

The main purpose of the event was to undertake a workshop for Trinidadian and Tobagonian stakeholders to provide an overview of the current electrical vehicle standardization landscape and to answer questions to support the building of a safer infrastructure for electric vehicles, as well as the finished vehicle — including parts and accessories.
