Formulated to be compliant with European Eco-label certification including Blue Angel, Austrian & Eu Ecolabels and Nordic Swan. Contains a minimal percentage of VOCs (<10%) and as it does not represent an environmental hazard, it is classified as non-hazardous for transport purposes.

This fount has been designed to work with both UV and Conventional inks. Suitable for use with all plates, inks, and dampening systems. It is a complete product that will print sharper and give clean, quick start. ups with a definite reduction in ink consumption.

- Recommended dosage of 2.00 - 4.00%, depending on local water conditions. Fount for normal water conditions < 15 degrees German hardness < 250ppm Calcium Carbonate.
- Follow relevant Good Manufacturing Practice (GMP) guidelines if used for the production of food packaging.
- Typical IPA levels 0.01-5.00 %.
