Shelf life and storage	Recommended storage temp. 10-25 °C. Protect from frost and heat. Direct sunlight should be avoided to prevent polymerization. Stable for a minimum of 12 months from the date of manufacture.
Special notes	To get optimal results, we recommend an accurate control of the polymerization process under the UV lamps.
Packaging	25 kg pails, 200 Kg drums, 1000 Kg tanks
Substrates	Coated papers and cardboards for packaging as well as collapsible boxes. Suited for Corona pre-treated PE film and Corona pre-treated PP film.
	In view of the wide substrates offered by various manufacturers, we recommend carrying out your own tests before starting a print run.
Printing Process	Varnishing units with chambered doctor blade (varnish amount approx. 4 – 6 g/m ²) Flexo printing (varnish amount approx. 3 – 4 g/m ²)
	Stir varnish thoroughly before use!
Exceptions	Not for use on food packaging without functional barrier.
Viscosity	approx. 30 sec/20°C, DIN 4mm-cup
