



Through immigrant and refugee correspondence, studies, reports, organizational and administrative files, and more, this archive considers the causes, effects, and responses to refugee crises across the world. Uncover the hidden histories of those who were forced to flee, migrate, and resettle inside and outside national borders due to war, the Holocaust, and ethnic and political persecution—and examine the relief, resettlement, and repatriation efforts that followed.

## REFUGEES, RELIEF, AND RESETTLEMENT: THE EARLY COLD WAR AND DECOLONIZATION

With over 110 million individuals presently dislocated by war, famine, economic decline, and environmental disaster, refugee crises have become an ever-more visible part of our daily global reality. This collection chronicles the causes of refugee crises following World War II, from the onset of the Cold War to the decolonization of, and rise of independence movements within, the nations of Africa, Asia, and the Middle East. Explore government files, refugee agency reports, and other materials that explain the challenges faced by those forced to flee, as well as the government and agency operations that sought to provide some form of relief through resettlement or repatriation.

This second installment in the new *Environmental History* series focuses on the environmental impact of colonial policies on colonized peoples, exploring themes such as “envirocolonialism,” land use and exploitation, exploration, agriculture, the technological revolution, industrial change and urbanization, conservation, pollution, climate, development programs and sustainability, natural resources, and industries such as forestry and mining.

### VALUE OF THE ARCHIVE

- **Quantitative Data:** Provides data useful for researchers tracking historical trends in climate change as well as environmental factors such as rainfall.





# CHATHAM HOUSE ONLINE ARCHIVE: MODULE 3

**Module 3** of *Chatham House Online Archive* picks up from the most recent installment, covering events that have defined the early twenty-first century, including the Arab Spring, the 2014 conflict in Ukraine, the road to Brexit, international financial crises, and much more. Many of the recorded meetings are subject to the Chatham House Rule, which states, "When a meeting, or part thereof, is held under the Chatham House Rule, participants are free to use the information received, but neither the identity nor the affiliation of the speaker(s), nor that of any other participant, may be revealed." Names and affiliations, therefore, will be redacted from the text where relevant to the rule, or a summary will be substituted.



## MODULE 1: 1920–1979

**Module 1** includes issues and discussions from the Paris Peace Conference in 1919 through World War II, the Cold War, the Suez Crisis, and up to the fall of the Shah of Iran in 1979.

## MODULE 2: 1980–2008

**Module 2** covers European integration, the fall of the Berlin Wall and the end of Communist rule in Russia and Eastern Europe, the Cold War, the continuing conflict in the Middle East, the end of apartheid in South Africa, the rapid expansion of globalization, and concerns for climate change.



## DECOLONIZATION: POLITICS AND INDEPENDENCE IN FORMER COLONIAL AND COMMONWEALTH TERRITORIES

Connect researchers to the crucial voices of local players who helped forge their country's new direction during the twentieth century. This collection offers firsthand perspectives to explore decolonization as a historical process in which over 70 countries and territories emerged from colonial or imperial structures into independence.

Largely eschewing the accounts of European colonial powers, the archive helps researchers explore decolonization as a process sparked from within, specifically the changing or adapting of systems from an imposed imperial or colonial structure after 1945. Examine national political developments that followed decolonization, discover how former colonies negotiated their own agency and futures, and compare different political movements within newly independent countries and commonwealth territories to see how and why self-rule developed differently in each region.

## WOMEN'S STUDIES ARCHIVE: FEMALE FORERUNNERS WORLDWIDE

This fourth installment of the multi-award-winning *Women's Studies Archive* focuses on individual women and organizations around the world who have broken new paths in society through business, social reform, popular culture, health care, and more. Provide researchers with primary sources that cover three centuries of women's history, including contributions of African American women trailblazers, nursing journals from around the world (including Britain, Australia, Africa, Asia, and the Caribbean), popular magazines from Australia and New Zealand, and collections concerning the supernatural and crime.


