1 Introduction

This report investigates citations from academic journal articles to monographs indexed in Gale's *Nineteenth Century Collections Online* (NCCO). This is an online searchable collection of documents primarily in English and published during the nineteenth century. Although the collection includes many types of documents other than monographs, the focus here is on monographs for the pragmatic reason that citations to other types of documents are technically difficult to discover. This is Gale's description:

Nineteenth Century Collections Online is the result of partnerships between Gale and almost one hundred libraries to preserve and make digitally available content for academic research. [] Nineteenth Century Collections Online unites multiple, distinct archives into a single resource of over one hundred types of primary source documents. The content [] consists of monographs, newspapers, pamphlets, manuscripts, ephemera, maps, photographs, statistics, and other kinds of documents in both Western and non-Western languages.

The purpose of this report is to illustrate a range of reasons why Gale's nineteenth-century monographs are cited, highlighting the value of the collection and potential use cases. Of course, most users are probably students whose work is marked rather than published, and there is no access to their work to identify how they use or cite the monographs. Thus, this report is illustrative and does not represent most users or document types.

The monographs are typically solo-authored nonfiction or poetry and vary from academic treatises to published memoirs. As confirmed by the reasons for citing the monographs, the nineteenth century was an interesting period of rapid social, technological, and political changes (Buzan & Lawson, 2013). It was also a time of changes in the printing and publishing industry in terms of technology, formats, and authors (Finkelstein & Nash, 2024). This period saw the first widespread publishing of autobiographical works from all social strata, and particularly the working class, providing firsthand evidence of daily life throughout society (Vincent, 2016). This was a byproduct of lowering printing costs and increasing access to the ability to learn how to read and write. This is reflected in many of the citations targeting relatively lesser-known documents, such as Life of a Licensed Victualler's Daughter by Mary Ann Ashford (1787–1840).

The analysis covers the main subject areas of papers citing monographs within *Gale's Nineteenth Century Collections Online*, the types of citing academic documents, the most frequently citing academic journals, and the most frequently citing academic institutions. In addition, it reports some broad themes that are common to many citing journal articles and gives examples of a range of different contexts in which academic researchers have found the monographs useful to cite. This information has been extracted from Scopus by running a search for the monograph titles in the reference sections of Scopus-indexed papers and books. To reduce false matches, monographs with short or common titles were omitted. The themes reported in this document were found by reading the text of the citation in the citing article.

2 Main subject areas citing the nineteenth-century monographs

This section illustrates which subject areas and people cite nineteenth-century monographs and why, focusing on the more obscure documents in the collection and based on very broad descriptive statistics. For this section, only documents in Gale's *Nineteenth Century Collections Online* that have been cited 10 times or fewer in Scopus are included. For convenience, these are described as "rarely cited monographs" below.




Figure 1. The types of documents citing rarely cited NCCO monographs.

The monographs are mainly cited by books, including book chapters, although a sizeable minority of journal articles also cite them (Figure 1). The dominance of book formats reflects the importance of the collection to the humanities and for longer format academic discussions. Scopus is much more comprehensive in its indexing of journal articles, so this graph underestimates the importance of books for citing the monographs.




Figure 2. The Scopus broad subject areas of documents citing rarely cited NCCO monographs.

Whilst most citations to the nineteenth-century monographs originate from the arts and humanities, the social sciences are also well represented, as well as a scattering of other subject areas (Figure 2). The reason for this pattern will be clear from the next section.

Broad insights into the topics of articles citing the monographs can be obtained from the title of the publishing journals, including those that publish the most citing articles (Table 1). The titles reflect a wide range of topics, including labour history, religion, and history.

The keywords of the citing papers (that have them) can also give insights into the topics of the citing articles (Table 2). These confirm the labour history, religion, and history topics identified above from the journal names but also suggest other topics, including politics and linguistics.

A majority of the papers citing the monographs had UK-affiliated authors, with mainly English-speaking and formerly UK-connected countries dominating the rest (Table 3). Nevertheless, a wide range of other countries are also represented.

The authors of the citing papers are mainly from well-known British universities, although well-known institutions from other mainly English-speaking countries are also well represented (Table 4). The list of other institutions is long, showing that the nineteenth-century monographs are widely valued by academic researchers.

3 Reasons for citing Nineteenth Century Collections Online documents

This section illustrates why *Nineteenth Century Collections Online* monographs have been cited in peer-reviewed academic journal articles with a few examples, split into themes. These themes overlap considerably and were selected to showcase a range of contexts in which the documents were cited. The information is often UK-based but other countries are mentioned, when relevant.

3.1 Daily life

Studies of daily life may cite *Nineteenth Century Collections Online* documents as a source of direct evidence (Table 5). These often cite specific facts from memoirs that might have disappeared if they had not been included in a published autobiography. Daily life is a wide topic that all the contexts seem very narrow, in contrast.

3.2 Drama

Monographs as a source of evidence about the production or staging of plays (Table 6). These examples do not cite the play itself but discussions of the writing or staging of them. For example, in Chartist Drama: The Performance of Revolt, the cited work Home Memories and Recollections of a Life provides evidence that Chartist dramatic societies often repurposed existing materials for their theatrical productions. Romanticism and Deaf Justice references Memoirs of the Late Thomas Holcroft to highlight Holcroft's involvement in translating a French play on deafness while residing in Paris, underlining the crosscultural dimensions of nineteenth-century drama.

3.3 Education

The nineteenth century was a time of expanding education in Britain, with attempts to gain access for working people and women (Table 7). The monographs include firsthand accounts of these attempts, both in terms of autobiographical information and polemics.

3.4 Family

Family life seems to have been under strain in the nineteenth century, including a relaxation of the institution of marriage in some places and various threats to bringing up children with their parents (Table 8). Outside of villages, new institutions and strategies were needed to look after children when their parents were unable to.

3.5 Gender roles

The nineteenth century seemed to be a harsh era for women, but they increasingly resisted being marginalised or taken for granted (Table 9).

3.6 Health

There is some interest in health-related issues from the nineteenth century, with information culled from firsthand accounts and polemics (Table 10). These citations demonstrate how historical texts inform contemporary understanding of health and medical history. For example, a study on contraception referenced a nineteenth-century essay to highlight early legal battles over birth control literature.

3.7 International

This section does not have a single topic but instead illustrates international issues or the monographs cited for countries or regions other than Britain (Table 11). Geographical terms are bold to emphasise them.

3.8 Linguistics

Linguistics seemed to be emerging as a modern research area in the nineteenth century, but with important contributions from a bishop (Table 12). In particular the cited work shows a turn from telling people how to use a language to accepting how people speak it.

3.9 Literature

As mentioned above, the nineteenth century saw the emergence of wider social classes of authors, transforming English literature. Many of the citations here are related to this (Table 13). Modern scholars draw on nineteenth-century autobiographies and polemical essays from *Nineteenth Century Collections Online* to illuminate several recurring subthemes:

- Working-class self-representation Autobiographies by John Younger, Ellen Johnston, "A Social Atom," and a private soldier are mined to show how labouring writers positioned themselves: as critical witnesses to elite stereotypes, as patriots who downplayed sectarian divides, as individuals within a collective class, and even through the very job labels in their book titles.
- **Gender and reading cultures** Studies of women's verse and domestic reading practices use these texts to trace how working-class women negotiated public voice and literary taste.
- **Transatlantic influences** One article demonstrates that British working-class memoirists consciously echoed the narrative strategies of American slave narratives, highlighting cross-cultural currents.
- National literary identity Poe-era criticism of "The importance and means of a national literature" is cited as part of an early U.S. argument for valuing indigenous writing over foreign judgments.

• Maritime life writing – Research on nautical careers turns to Frank T. Bullen's Log of a Sea-Waif to reconstruct sailors' global mobility at the century's end.

Together, these citations show how nineteenth-century life-writing serves contemporary scholarship as firsthand evidence of class experience, gendered authorship, national literary debates, and occupational subcultures.

3.10 Music

Two very different citations focused on music: one from the perspective of the amateur casual performer and the other from the perspective of organising concerts (Table 14).

3.11 Philosophy

Philosophical questions were extensively debated in the nineteenth century, often relating to religion (Table 15).

3.12 Political movements

The nineteenth century saw many political changes and social unrest from the working classes. Firsthand evidence of these from participants and supporters can be obtained from autobiographies, contemporary treatises, and reports (Table 16).

3.14 Poverty

Poverty became a prominent issue for some during the nineteenth century, including as a result of government surveys (Table 18). Firsthand accounts give evidence about the harsh steps to help those most in need.

3.15 Publishing and printing

Publishing and printing technology changed substantially during the nineteenth century and those within the industry had more ready access to the means to publish about their experiences. Thus, surprisingly many articles cite about this ostensibly narrow topic (Table 19).

3.16 Religion

Religion was a common topic of discussion, due to challenges from science and tensions between various Protestant ideas and Catholicism (Table 20). Many of the citations in this section are related to religious disputes, which are clearly still of historical interest today.

3.17 Science and Technology

Science and technology greatly expanded their economic and social influence during the nineteenth century. Some scientific issues were also controversial, leading to public interest and debates (Table 21).

3.19 Working class life

Three papers related to crime and the law in China (Table 14). For example, a paper focusing on Qing era wills cited evidence that English judges did not understand the existing system of wills and inheritance.

4 Summary

This report has identified a wide range of themes in peer-reviewed academic journal articles citing monographs from Gale's *Nineteenth Century Collections Online*. These citations illustrate the rich historical significance of the nineteenth century—a period marked by major social, political, and technological change, as well as transformations in publishing and the broadening of authorship beyond the elite.

The diversity of citation contexts demonstrates the collection's broad academic relevance. Researchers have used these monographs to support studies in social history, literature, political movements, religion, education, science, gender studies, and more. Many citations draw on autobiographical texts, offering unique insights into daily life, working-class experiences, and the perspectives of individuals often marginalized in traditional historical narratives.

The collection is especially relevant to scholars in the arts, humanities, and social sciences, not only for understanding nineteenth-century life but also for tracing the origins of contemporary issues. These monographs provide authentic, often firsthand accounts that are difficult to find elsewhere, making them a useful resource for nuanced, evidence-based academic research.
