

EXPAND UNDERSTANDING OF THE IMPACT OF THE EIGHTEENTH CENTURY

Eighteenth Century Collections Online (ECCO) is the definitive primary source for research into the transformative events and ongoing impact of a pivotal century—from revolutions to the rise of literature to the expansion of colonization. With the release of Part III, researchers will gain access to 1.7 million pages of relevant content previously unavailable in digital form, including global perspectives from the Americas, Asia, and Australia as well as unique content types in unusual formats and sizes. ECCO III will equip scholars to make new research connections and enhance instruction in eighteenth-century studies and beyond.



VALUE OF THE COLLECTION

For over two decades, scholars have explored essential eighteenth-century content in *Eighteenth Century Collections Online*, more familiarly known as ECCO. Made possible by an ongoing collaboration between leading libraries such as the British Library and Gale, ECCO offers researchers across disciplines millions of pages of materials to uncover eighteenth-century events and perspectives.

With ECCO, Gale aspires to deliver a definitive archive of every title published in eighteenth-century Britain and its colonies. The collection is based on the English Short Title Catalog (ESTC), a scholarly resource managed by the British Library and the University of California, Riverside, which lists early books, serials, newspapers, and selected ephemera printed before 1801. After digitizing this microfilm collection, Gale released ECCO I in 2003 and ECCO II in 2009. Since then, ECCO has been called "the primary digital source for the study of printed eighteenth-century texts in the English language,"* and has enabled scholars to further their careers by supporting a wide array of eighteenth-century research projects.

But the collection is not yet complete.

What's missing from Part I and Part II?

- The microfilm project did not represent all the titles listed in the ESTC, which also continued to add entries after the publication of *Part II*.
- Limits in previous technologies prevented the microfilm project from scanning large and unusually formatted titles.
- Although Part I and Part II were created using the best available microfilm scanning technology at the time, many titles went uncaptured until Gale committed to scanning archival materials in full color not included in the original microfilm set.

Eighteenth Century Collections Online, Part III fills these gaps and expands possibilities for researchers even further by providing access to approximately 1.7 million pages of rare and relevant eighteenth-century materials previously unavailable in digital form. Scholars will gain access to high-quality, full-color images from original source content, including unique texts in unusual formats and sizes, such as broadsides covering various subjects and comprising thousands of illustrated works.

Available on the user-intuitive Gale Primary Sources platform, ECCO III equips researchers to analyze how a century of transformative ideas shaped our modern world. Scholars will find more essential material to trace revolutions in France, America, and Haiti; explore how the birth of the novel shaped literature and the rise of literacy; and understand the lasting impacts of European empires who imposed their control and culture on Indigenous peoples.

ECCO III expands the world of eighteenth-century research into global perspectives, offering coverage of major eighteenth-century events in Australia, the Americas, Asia, and Europe. Researchers will have access to newly digitized material to pursue more in-depth exploration and analysis across disciplines, including history, economics, linguistics, social sciences, politics, literature, science, and medicine.
