

## LIMITED WARRANTY ON ORIGINAL ENDLESS POOL™, STREAMLINE®, AND WATERWELL® FITNESS SYSTEMS

Wellness Marketing Corporation (“WMC”) warrants to the original purchaser (“you”) all parts of the Original Endless Pool™, Streamline® and Waterwell® fitness systems (“Product”) to be free from defects in material and workmanship for two (2) years from the date that the product is received by the original purchaser or their authorized representative (installation contractor, etc.). In addition, WMC warrants to you all parts of the steel wall panel system (“Panel”) to be free from manufacturer defects beyond structural use for ten (10) years from the date that the product is received by the original purchaser or their authorized representative (installation contractor, etc.). This warranty is not transferable.

### What We Will Do

WMC will, at its sole discretion, repair or exchange, free of charge, during the warranty period (as described above), any part on Product that proves defective in material and/or workmanship under normal installation, use and service. WMC will, at its sole discretion, repair or replace Panel after receipt and inspection of the defective panel. The structural warranty on Panel is voided when suitable drainage is not provided, and/or panels are not properly bonded, as stipulated in the installation instructions. **This is your exclusive remedy.**

### What Is Not Covered

Any labor charges incurred by you to repair, replace, install or remove this product and all freight charges are not covered by this warranty. WMC shall not be liable for any damage to the product resulting from reasonable wear and tear, misuse (including use of the product for an unintended application), acts of God, freezing water, water ph levels outside of the range of 7.4 to 7.8, water alkalinity levels outside of the range of 80 to 120 ppm, a total dissolved solids (TDS) level that exceeds 3,000 ppm, abuse, neglect or improper or incorrectly performed installation, maintenance or repair, including failure to follow the applicable care and cleaning instructions. WMC recommends using a qualified and licensed professional for all installation and repair of the Product and Panel.

### What You Must Do To Obtain Warranty Service or Replacement Parts

WMC SHALL NOT BE LIABLE FOR ANY DAMAGE TO THE PRODUCT RESULTING FROM REASONABLE WEAR AND TEAR, MISUSE (INCLUDING USE OF THE PRODUCT FOR AN UNINTENDED APPLICATION), ACTS OF GOD, FREEZING WATER, WATER PH LEVELS OUTSIDE OF THE RANGE OF 7.4 TO 7.8, WATER ALKALINITY LEVELS OUTSIDE OF THE RANGE OF 80 TO 120 PPM, A TOTAL DISSOLVED SOLIDS (TDS) LEVEL THAT EXCEEDS 3,000 PPM, USE WITH SALT CHLORINE GENERATORS, ACCIDENT, ABUSE, NEGLIGENCE OR IMPROPER OR INCORRECTLY PERFORMED INSTALLATION, MAINTENANCE OR REPAIR, INCLUDING FAILURE TO FOLLOW THE APPLICABLE INSTALLATION, CARE AND CLEANING INSTRUCTIONS, AND FLOW RESTRICTIONS OR OBSTRUCTIONS ON ALL WATER AND HYDRAULIC SYSTEMS.
