Overview

i-Ready Diagnostic (including the i-Ready Diagnostic for Mathematics in Spanish, i-Ready Evaluación Diagnóstica de lectura en español for Grades K-6, and i-Ready Growth Monitoring unless otherwise noted), i-Ready Standards Mastery, and i-Ready Assessment of Spanish Reading for Grades 7 and 8 offer accessibility features that are available to students based on student preference. Because these features are available to students regardless of disability, IEP, 504, or English Learner plan—any student who uses i-Ready can make the choice as to whether or not they will use the available accessibility features. If you are looking for accommodations information related to i-Ready Literacy Tasks, please reference this guidance document.

What kind of supports and accommodations are available to students?

An accessibility feature can be enabled by an educator for students based on student preference. These features are available to all students, regardless of their disability status, English proficiency level, or any other type of documented need. Any student who uses i-Ready can make the choice as to whether or not they will use an available feature.

A designated support may be enabled for students where the need has been indicated by an educator (or team, including the parents/guardians and the student, if appropriate) who is familiar with the student's characteristics and needs.

An accommodation is a change to procedure or process to increase equitable access to i-Ready for students with disabilities. Accommodations are only for students who have a documented need, as expressed in an IEP, 504, or English Learner plan, for use of a given accommodation. In the case of i-Ready Assessment, accommodations allow students with disabilities to demonstrate their knowledge and receive a valid assessment score.

How can accessibility features in i-Ready Assessment be enabled?

Educators do not need to turn any accessibility features on or off in i-Ready as these features are available for immediate use.

The Diagnostic, Growth Monitoring, and Evaluación Diagnóstica de lectura include universal audio support. Audio support is also available as a designated support and/or accommodation. Are *i-Ready* assessments compatible with third-party text-to-speech tools?

Although some third-party browser extensions may be able to read aloud some portions of the text in the Diagnostic, Assessment of Spanish Reading, and Standards Mastery, the use of these extensions is not recommended at this time, as compatibility and usability show a high degree of variance based on the item type, extension, browser, hardware, etc. In the Diagnostic for Reading and Evaluación Diagnóstica de lectura, educators can enable editorially vetted audio support as either a designated support or an accommodation where universal audio is not available. In i-Ready Standards Mastery, we are actively exploring an embedded solution for text-to-speech.

Are i-Ready assessments compatible with screen readers and/or refreshable braille displays?

The Diagnostic has been tested with JAWS®, NVDA, and VoiceOver with specific browser combinations. Curriculum Associates is currently testing the validity and usability with refreshable braille displays. Each of the screen readers that have been tested can also be used with some refreshable braille displays. Educators should refer to documentation on the student's screen reader and refreshable braille display before determining if the accommodation is appropriate for the student. Further usability updates to our products will be informed by our partnership with third-party accessibility and Universal Design for Learning advisors and our internal Usability Testing team. Screen-reader testing with other i-Ready assessments is ongoing.

Do *i-Ready* assessments have paper options or print functionality?

The Diagnostic is a computer-adaptive assessment. As a student answers questions correctly or incorrectly, the Diagnostic responds, adjusting the difficulty of future questions to match the student's individual ability. The strength of this assessment is its ability to continuously adapt, therefore, a paper version does not exist. Similarly, due to the interactive nature of the Assessment of Spanish Reading and Standards Mastery item types, paper versions are not available.

What supports can teachers provide for tactile graphics during the Diagnostic?

i-Ready Diagnostic includes user-interface elements and test item images, including some complex graphics, that have been enhanced with alt text. There are some instances when a student may request or require a tactile graphic to access a test item enhanced by alt text. Because the i-Ready Diagnostic is a computer-adaptive assessment, notification about the need for a tactile graphic cannot be provided to teachers before the assessment is administered. We are actively engaged with the American Printing House for the Blind to improve our delivery of tactile graphics to support students who are blind or have low vision. This guidance brief provides educators with information about how to create tactile graphics on demand.

Why is audio support in the Diagnostic for Reading and Evaluación Diagnóstica de lectura available as a designated support or an accommodation? How can it be enabled?

Due to differences in state and local policies related to audio support, we offer read-aloud support nationally as both a designated support and an accommodation. Reports will indicate whether a student was provided read-aloud support, but i-Ready will not track or indicate if it was provided as a designated support or an accommodation. Additionally, difference in state and local policies determine whether read-aloud support can be provided for reading passages. If a state's policy allows for audio support of reading passages, it will be available as such in the i-Ready platform. For more details, please reference this guidance document.
