

# The Relationship between *i-Ready Diagnostic* and the 2023 Illinois Assessment of Readiness (IAR)

Curriculum Associates Research Brief | December 2023

## **Research Overview**

*i-Ready Diagnostic* and the 2023 IAR are highly correlated—with an average spring correlation of .79 for English Language Arts/Literacy (ELA/L) and .89 for Mathematics.

## About the Students Included in the Study

Curriculum Associates conducted a large-scale study on the relationship between the *i-Ready Diagnostic* and the 2023 IAR for Grades 3–8 in ELA/L and Mathematics, the primary grades in which *i-Ready* is used in Illinois for which there is a state summative assessment in place. Students came from a total of 11 school districts, all public and none of which were charter agencies (see Table 1). The school districts were selected for participation in the study specifically to be representative of the state in terms of factors such as urbanicity, race/ethnicity, and socioeconomic status (using National School Lunch Program as a proxy). 

# **Correlation Results**

Across all grades and in both subjects, results provide evidence for the strong correlation between *i-Ready Diagnostic* and the IAR (see Figure 1). Specifically, spring correlations for ELA/L ranged from .77 for Grade 8 to .81 for Grades 3 and 5, and spring correlations for Mathematics ranged from .87 for Grade 8 to .89 for Grades 4, 5, 6, and 7. These correlations, **all surpassing the .70 standard generally considered to be strong in education research**, provide evidence of a substantial relationship between *i-Ready Diagnostic* and the IAR.

## Why Correlations Matter

Correlations are one of the most commonly used and widely accepted forms of validity evidence. Correlations demonstrate that when students score high on one assessment, they also tend to score high on the other, and similarly, when students score low on one assessment, they also tend to score low on the other. A high correlation between two assessments provides evidence that the two assessments are measuring related constructs.



## Appendix

The sample included more than 40,000 students, with between 6,027 and 6,478 students per grade for ELA/L for the spring *i-Ready* assessment and between 5,679 and 6,858 students per grade for Mathematics for the spring *i-Ready* assessment (see Table 2). These students took both the *i-Ready Diagnostic* and the IAR during the 2022–2023 school year.

Table 3 shows the percentage of students in each race/ethnicity group from the study samples. In both the ELA/L and Mathematics samples, we have strong representation from students of different racial/ethnic groups.
