

Global Warranty Statement

All products sold by Spacestor are backed by our 7-year warranty, except as limited or described below.

5 years*

Upholstered products

2 years

Moving parts (Hinges, handles, runners, locks, motors, fans, electronic controls and mechanisms, mechanical and electronic lift/movement mechanisms etc)

1 year

Light ballasts, bulbs and power supplies

*based on 8-hour use environment. Reduces to 2 years in 16-hour use environments and one year in 24-hour use environments

Spacestor warrants the products sold by it to be free from defects in material and workmanship for the warranty periods specified. During the applicable warranty period, Spacestor will repair or replace (at its option) any product, part, or component covered by this warranty and sold after the effective date of this warranty, which fails under normal use as a result of a defect in material or workmanship.

Spacestor will repair or replace the aforementioned product, part, or component with a comparable product, part, or component.

This warranty extends only to the original purchasers who acquire new product from Spacestor, or its authorised resellers.

Any product, part, or component must have been used according to Spacestor's published instructions and installed and maintained by a Spacestor-trained technician or an authorised installer. Any misuse, abuse, or modification to the original product voids the warranty.

The warranty period starts from the date of purchase.

We expect a full 10 year product continuity on our standard products, subject to external factors such as availability of finishes, parts and regulatory requirements
