


Provincial Attestation Letter – Bayswater PAL Process

Who requires a PAL:


- Programs that are longer than 6+ months (at least 26 weeks)
 - 6+ months of ESL/Pathway
 - Bayswater PCC
- Students who:
 - Submitted study permit applications after 8:30 a.m. ET on January 22, 2024
 - Do not have an active study permit application





Who DOES NOT require a PAL:

- Programs that are less than 6 months (24 weeks)
 - \circ $\,$ 24 weeks or less of ESL $\,$
 - o Short-term groups
 - Valid work permit
- Students who:
 - Submitted study permit applications <u>before</u> 8:30 a.m. ET on January 22, 2024
 - Have an approved study permit already
 - o Have an active study permit and are already in Canada






• Student Profile:

- Priority is long-term programs 28+weeks to a year (PCC, or ESL/Pathway)
- o 25-27-week bookings will be reviewed on case-by-case basis.
- Recommend use of the **PALS form** to assess student profile

PAL Allocations:

- Student details <u>cannot</u> be modified after a PAL is issued.
- Information on LOA, PAL & Study Permit Application must match.
- It is <u>very important</u> to review student details before PAL submission.





Please note, that each issued PAL will count towards Bayswater's allocation.

Therefore, in the case of:

- **Study permit denials:** a new PAL won't be issued to support reapplication. Students are requested to withdraw and request a refund (as per Terms and Conditions)
- Deferrals:
 - <u>New start date before January 21, 2025</u>: no need to issue a new PAL. Can proceed with deferral request.
 - Expiry Date of Submission January 21, 2025: All PAL applications must be submitted by this date. This does not affect the start date of the course.






Application Process and Required Documents:

- PAL request form: To help us review the eligibility of the student's profile when applying for a study permit, each PAL request must fill in our PALS form
- This must be submitted alongside our standard Application
 Form and Passport

Deposit Payment:

- PAL Deposit Payment: <u>\$750 deposit (</u>\$185 non-refundable, \$565 deposit).
- Refund: \$565. To apply for a refund, you <u>must provide proof</u> <u>of refusal</u>. Please be aware that refunds will not be issued if cancellation is due to personal reason.








PALS Process

- Application: Send Admissions the following: Application Form & Passport
 - Complete PAL Request Form
- PAL Review: Bayswater to review Application, Passport and PAL request Form
- Deposit: Bayswater to issue LOA (To be reviewed) & Deposit \$750 Invoice issued
- **Payment:** Payment is made, and PAL is requested by Bayswater.
- PAL: PAL received, and Study Permit application is made.

For those not applicable for a PAL, you can still study in Canada! We recommend applying for a shorter study period and still taking advantage of what Canada has to offer.

Please note that Bayswater Toronto, Vancouver and Calgary are accepting PAL requests on a case-by-case basis. Feel free to send your bookings to us!
