


## Safety Information and Warnings

### **IMPORTANT NOTE: LOCAL CODE**

Local codes and regulations that are more stringent than the requirements in this manual take precedence over Ortal requirements.

### **WARNING: REVIEW ALL WARNINGS**

Be sure to review all safety warnings and installation guidelines contained in this manual. Consider installation location, vent configuration, clearances, structural requirements, framing and finish materials, and local codes. ALL warnings and instructions apply to all products manufactured and distributed by Ortal.

### **WARNING: DO NOT OPERATE FIREPLACE IF:**

The glass is NOT properly secured in place; Connection points are not sealed (for fireplaces with glass-to-glass connections); Glass is cracked; You smell gas; Any part of the fireplace has been under water; You have any doubt about the safe operation of the fireplace. Immediately call a qualified, professional service technician to inspect the fireplace and to replace any parts of the control system and any gas controls which have been underwater.

### **WARNING: ELECTRICAL GROUNDING**

All electrical connections must be properly installed, insulated, and secured to avoid potential **ELECTRICAL SHOCK** and **FIRE HAZARD** and malfunction of the system. Consult local building code requirements. In the absence of local codes, refer to the National Electric Code, ANSI/NFPA 70, or the Canadian Electric Code, CSA C22.1.

### **WARNING: MATERIAL USAGE**

All materials and objects used to carry out the installation must be certified/approved or specified by Ortal and are suitable for use. Do NOT install the system with different materials or objects than those approved for installation by Ortal.

### **WARNING: INSTALLATION AND SERVICE**

Installation and repairs on the fireplace and vent system must be done by an authorized Ortal qualified installer service agency or gas supplier. If these components are not installed by an authorized Ortal dealer/installer, the warranty of all components will be void and Ortal will not be responsible for any damage caused by improper installation. The fireplace should be inspected before use and at least annually by a professional service person. More frequent cleaning may be required due to excessive lint from carpeting, bedding material, etc. Control compartments, burners and circulating air passageways of the fireplace must be kept clean. Any alteration to the product can cause soot or carbon to form and may result in damage. This damage and any other damage that results from not following the instructions outlined in this manual is not the responsibility of Ortal.

### **WARNING: HEAT BARRIER**

A barrier designed to reduce the risk of burns from hot viewing glass is provided with this fireplace and shall be installed. The fireplace **MUST** not be used without the heat barrier in place. If the barrier becomes damaged, the barrier shall be replaced with the manufacturer's barrier for this fireplace. **Any safety screen, guard, or barrier removed for servicing the fireplace must be replaced before operating.**

### **WARNING: FIREPLACE TEMPERATURE**

Due to hot temperatures, the fireplace should be located out of traffic and away from furniture and draperies. Children and adults should be alerted to the hazards of high surface temperature and should stay away to avoid burns or clothing ignition. Clothing or other flammable material should not be placed on or near the fireplace. **Young children should be carefully supervised when they are in the same room as the fireplace.** Toddlers, young children, and others may be susceptible to accidental contact burns. A physical barrier is recommended if there are at-risk individuals in the house. To restrict access to a fireplace or stove, install an adjustable safety gate to keep toddlers, young children, and other at-risk individuals out of the room and away from hot surfaces.

### **WARNING: GLASS HANDLING**

Only an Ortal certified installer is authorized to remove the glass using an 8-inch glass-handling suction cup.

### **WARNING: INSTALLATION AND OPERATION**

The fireplace and accompanying components must be installed as an OEM installation in manufactured homes (USA only) or an aftermarket permanently located, or a mobile home, where not prohibited by local codes. The fireplace must be installed in accordance with the Manufacturer's instructions and the Manufactured Home Construction and Safety Standard, Title 24 CFR, Part 3280, in the United States, or the Standard for Installation in Mobile Homes, CAN/CSA Z240 MH Series, in Canada. **Exceeding the restrictions imposed in these instructions may result in a fire or explosion, causing property damage, personal injury, or loss of life. Ortal will not be responsible for any damage caused by improper installation. Do not store or use gasoline or other flammable vapors and liquids near this fireplace.**

### **WARNING: GAS FIREPLACE**

This fireplace is for use only with the type of gas indicated on the rating plate. These fireplaces are not convertible for use with other gases unless a certified kit is used, and the conversion is performed by an authorized and qualified technician. Applicable standards are Vented Gas Fireplace Heaters ANSI Z21.88 / CSA 2.33a and Gas-fired Fireplaces for Use at High Altitudes CAN/CGA 2.17-M91

Installation is recommended in living spaces such as bedrooms, living rooms, great rooms, etc. The fireplaces are not approved for closet installation. The fireplace must be installed according to Ortal requirements in addition to any local codes that may apply, such as USA: ANSI Z223.1/NFPA 54, Canada: CSA B149.

- Consult the authority having jurisdiction to determine the need for a permit prior to starting the installation.
- It is the responsibility of the fireplace dealer and installer to ensure that this fireplace is installed and framed in compliance with these instructions and all applicable codes.


## General Product Information

The Wilderness Traditional Insert series requires; interior panel options (Brick options, Black Reflective Panels or Black Ridge Panels), a firelog set (Dark Brown or Chopped Wood), a surround and screened front to complete the installation. If any of these components are not present, please contact your authorized Ortal dealer. Wilderness Traditional Inserts are designed to be installed into solid fuel masonry or pre-manufactured wood burning fireplaces.

### **WARNINGS:**

- If the vent system of this appliance is disconnected for any reason, the vent and air intake systems must be properly reassembled and resealed before this appliance is put into use.
- Proper installation of the vent system, as required in this manual, is vital to the performance of this appliance. Oversights or failure to conform to all installation requirements will void the applicable warranty.
- This appliance must be properly connected to a venting system in accordance with the Ortal’s installation instructions. Operation of this appliance when not connected to a properly installed and maintained venting system can result in carbon monoxide (CO) poisoning and possibly death.
- Co-linear flexible aluminum venting must be professionally inspected periodically for corrosion and damage and be replaced when necessary. If the installation does not allow for future inspection or replacement of the flexible aluminum venting, then stainless steel vent liners should be used.
- Co-linear portion of vent system may only be installed within a solid fuel burning fireplace and chimney.
- The appliance must not be connected to a chimney flue serving a separate solid fuel burning appliance.

## Rating Label

The fireplace rating label is found on a metal plate separate included with the fireplace.

### DEALERS/INSTALLERS:

You **MUST** leave the fireplace's rating label with the fireplace in an area easily accessible by the owner (typically near the access panel, if available). You must instruct the owner before handing over the fireplace where this label can be found.

### OWNERS:

Make sure the installer leaves your fireplace's rating label in an area that is easily accessible for you. This information is required for servicing and receiving replacement parts.

# Installation Preparation

## Prior to Installation

### Locate the Fireplace

Keep the following factors in mind prior to installation in a masonry:

- Thoroughly clean the existing masonry chimney
- Properly inspect the chimney- if necessary, have repairs made by qualified personnel
- Ensure the masonry is constructed of non-combustible materials
  - *Exception:* The metal floor of the solid fuel firebox may be removed to facilitate the installation of the insert. Raising the unit  $\frac{1}{4}$ " using the leveling legs and placing on combustible flooring.

## Fireplace Installation

Use the following guidelines to ensure a smooth installation. The installation sequence is divided into three phases: Planning, Installation, and Startup.

### Planning

Consult with the contractor and go over all requirements:

- Clearances around the fireplace
- Installation to be completed on non-combustible flooring only
  - *Exception:* The metal floor of a solid fuel firebox may be removed to facilitate the installation of the insert. Raise the unit  $\frac{1}{4}$ " using the leveling legs and placing on combustible flooring.
- Gas and electrical specs and location
- Vent configuration

The plan to install a gas fireplace inside an existing solid fuel burning fireplace chimney must include inspection and cleaning of the fireplace cavity and the entire chimney system. The chimney top, especially masonry chimneys and wood framed chimney tops must be inspected, and the top surface must be repaired or replaced, if necessary. Unlined chimney flues are the most vulnerable to mortar corrosion and damage. These flues must be inspected, and repair must be done before dropping the flex vent liner for this Insert.

If you encounter a badly deteriorated or completely damaged firebox, do not proceed. These damaged structures must be reviewed by structural Engineers and Local Building Code officials must approve the repair work prior to this Insert being installed in such a damaged cavity.

### Installation

- Clear a path free of any possible obstruction to carry in the fireplace
- Unbox the fireplace
- Protect the fireplace and components from damage
- Install the vent components. See "Venting" section
- Fireplace conversion notice; permanently attach this notice inside the existing masonry fireplace
- Attach the co-linear vent liners to the slide plate and insert the fireplace into place
- Level the appliance

### Vent Installation

Venting must be installed according to the requirements detailed in the "Venting" section of this manual in conjunction with the vent system manufacturer's installation instructions. Venting must be supported by the structural surrounding and not by the fireplace.

Make sure that the chimney and masonry appliance are in a clean and sound condition and constructed of non-combustible materials. If necessary, have any repair work done by a qualified person before installing the insert. Remove the existing appliance damper or lock into an open position.

It is recommended that the liners be attached to the slide plate assembly with hose clamps. Due to the gauge of metal used on the slide plate, attaching the liners with screws will be difficult.

### Gas & Electrical

Gas and electrical components are located on the outer left side of the insert. For best results, it is recommended that the gas line and electrical outlet box be in the back left side of the existing masonry. See "Routing the Gas Line" and "Electrical Requirements" sections below on farther details.

### Conversion Notice

Each Wilderness Traditional Insert will be provided with a gas conversion notice. Permanently attach this plate inside the existing masonry.

 **WARNING! Risk of Fire! This fireplace has been converted for use with a gas fireplace insert only and cannot be used for burning wood or solid fuels unless all original parts have been replaced, and the fireplace re-approved by the authority having jurisdiction.**

## Startup

---

- Perform a visual inspection to confirm that all work was completed correctly and per specification
- Confirm that gas and electrical are properly connected and live
- Remove the front frame and glass to clean the inside of the fireplace
- Install media as specified in the “Firelog Set Up” and “Interior Design Media” sections
- Confirm media is set up per specification
- Confirm the fireplace is operating properly
- Check remote-control setup
- Remove protective layer from glass and clean glass
- Reinstall the glass and front frame
- Review operation of the fireplace and remote control with the owner
- Set up return visit to clean glass after the initial burning period (see “Post-Installation” section below).

## Post-Installation

---

Complete the following post-installation steps upon 2<sup>th</sup> trip to site.

### Initial Burning Period

---

There is a 12-hour minimum burning period following installation of the fireplace. This 12-hour period must include a minimum of 4 consecutive hours of continuous burning. During this time, the owner or installer may notice:

- The glass developing a white or “cloudy” residue.
- An unusual smell

Both the residue and the smell are due to the paint on the fireplace metal heating and “burning off”. This is normal. The cloudiness and odor will disappear after the 12-hour period elapses and the installer returns to service the fireplace and complete startup.

### Final Inspection Procedure

---

When the 12-hour burning period is complete, the installer must return and perform the final inspection, which includes:

- Cleaning the glass with a ceramic glass cleaner (otherwise the white residue will remain)
- Checking the interior media setup
- Checking for gas leaks
- Performing an overall check to make sure that everything is working properly.

When these activities are complete, initial startup is concluded and the fireplace may be operated by the owner.

### Final Checks and User Instruction

---

Before releasing the fireplace to the customer for use without installer supervision, the installer must ensure that the fireplace is burning correctly. In addition, the installer must review and explain the following to the owner:


- Safety warnings
- Fireplace operation
- Warranty requirements
- Maintenance requirements
- Glass is hot during and after operation.
- If any questions or concerns arise, owner must contact the local Ortal dealer/installer for support.


## Fireplace Dimensions

The following diagram depicts the physical fireplace dimensions. Use for reference only. For additional information on Minimum Fireplace Opening see the section on the next page.


### Wilderness Traditional Insert Dimensions








## → Minimum Fireplace Opening





**!** Note:  $\frac{1}{4}$ " Clearance is required on both sides, top, and back of the appliance. These clearances are already calculated into the dimensions shown above.


**!** Note: The  $\frac{1}{4}$ " clearance is a bare minimum dimension. For ease of serviceability, we recommend an additional 2  $\frac{1}{2}$ " inches to the "C" dimension (height). Otherwise, reattaching the slide plate to the top of the unit is extremely difficult and almost impossible.

## General Clearances

### Viewing Area Clearance Zone

The viewing area clearance zone is an area that extends perpendicular from the fireplace viewing area. The depth of the viewing area clearance zone depends on the combustibility of the material in question. Distance is measured from the fireplace heat barrier.

<b>Non-Combustible Materials</b>	Must be a minimum of <b>12 inches</b> from fireplace viewing
<b>Combustible Materials</b>	Must be a minimum of <b>16 inches</b> from fireplace viewing




**! IMPORTANT NOTE:** When placing material near the glass, take care to consider fireplace serviceability. It is strongly recommended that any items/materials placed in front of the front (long) glass be movable for easy access to the fireplace during servicing.

### Mantel Clearances


Comply with all minimum clearances in the two mantel sections below.

#### Combustible Mantels

Maximum mantel depth is 16 1/2" when combustible flooring or hearth is directly in front of the insert. Combustible flooring or hearth must remain below the bottom of the surround. Any finishing material that protrudes more than 3/4" is considered a mantel and must meet the mantel requirements listed in this manual. Mantel is required to be a minimum of 13" from the top of the front frame.



For combustible mantel depth greater than 16 1/2", a non-combustible floor or hearth must extend 10" from the unit. Non-Combustible flooring or hearth must remain below the bottom of the surround. A mantel is required to be a minimum of 13" from the top of the front frame.




**Non-Combustible Mantels**

Non-Combustible Mantels' only limitation is they must not overlap the surround. Construction of the non-combustible mantel can start right at the top of the surround and has no depth limitations.

**Combustible Mantel Legs or Side Wall Clearances**

Combustible Mantel Legs or Wall Projections must maintain a 4" clearance as shown below from the side of the front frame. Depending on size of surround installed, this 4" clearance might need to be extended to allow for surround removal.




**Non-Combustible Mantel Legs or Side Wall Clearances**

Non-Combustible Mantels' only limitation is they must not overlap the surround. Construction of the non-combustible mantel can start right at the edge of the surround and has no depth limitations.

## Chase Floor/Platform

The fireplace must be installed on a flat, solid, continuous surface. Surface can be concrete, metal, and other non-combustible floor types. Combustible flooring underneath the appliance is acceptable with a 1/4" minimum gap, by utilizing the leveling legs.



Side View


**Raised Platform Option:** To raise the fireplace higher, build a platform for the fireplace to stand on. Platform must be stable and able to bear the full weight of the fireplace. Platform must be constructed out of concrete, metal, or any other non-combustible materials unless you are raising the leveling legs a minimum of 1/4".

## Hearth Extension

A hearth extension is not required. **All flooring and hearth material must remain below the bottom of the surround.** Combustible flooring can be in front of the appliance. The temperature in front of the fireplace can get as high as 150°F above ambient temperature. While the fireplace certification allows for this temperature variance, building and finish materials will have their own limitations. Consult the material manufacturer to ensure the material can safely withstand this temperature range.

## Leveling the Appliance

Level the appliance before placing it into the final position in the existing masonry. Leveling the unit will eliminate rocking or excessive noise when the fans are in operation and help with finishing and aesthetics associated with that process. Level the appliance from side to side and front to back. Adjust leveling legs to desired vertical position so appliance is level on the flooring. Legs are adjustable from 0 to 1" and can be adjusted using a Phillips head screwdriver or an Allen Wrench depending on how you are adjusting the leg height.




- Using a 3mm Allen Wrench, turn the front 2 leveling bolts counterclockwise to the desired height.

# Venting

## General Venting Requirements

The fireplace operates using a direct vent system and requires co-linear vent pipe. The fireplace must be properly connected to an approved vent system. Venting is not provided with the fireplace and must be sourced from one of the approved vent manufacturers mentioned in the table below. Proper installation, use, and maintenance of venting is determined by and can be acquired from the vent manufacturer.





## Connecting the Co-Linear Vent Pipe

**WARNING:** Use stainless-steel band (hose) clamps to fix the chimney. Due to the gauge of metal used on the slide plate, self-tapping screw will be difficult to attach the liner.

- Guide the 4"x3" or 3"x3" flexible liners down through the chimney.
- Secure the 3" liner on the fresh air intake collar on the slide plate with the hose clamp using a 5/16" nut driver.
- Secure the 4" (IN34) or 3" (IN29) liner on the exhaust starting collar on the slide plate with the hose clamp using a 5/16" nut driver.
- All other proper installation, use, and maintenance of venting is determined by and can be acquired from the vent manufacturer.




## Vent Restrictors

A vent restrictor is a metal plate that reduces the flow of exhaust evacuating the fireplace. When 20 feet or more of vertical venting is used, a restrictor will need to be installed. Refer to the table below to determine which restrictor, if any, is recommended for your insert.


### Top Open

Keep a minimum **6-inch** clearance around the diameter of the cap's side edge and extending above and below the cap.



### Sides Open

Keep a minimum **6-inch** clearance around the diameter of the cap's side edge, and a minimum **10-inch** clearance above the top of the cap. For openings in the surround, make sure to allow for enough air flow space to release the exhaust gases and allow the vent to operate properly.



## Vent Maintenance

Regular inspection of the vent system by a qualified service technician is recommended every six months. The following maintenance routing is recommended:

- Inspect vent liners and termination cap for obstructions, such as debris and other elements, corrosion, and damage.
- Verify vent liners are securely attached to the termination plate.
- Check termination cap seal or flashing for possible gaps.

## Routing the Gas Line

The gas and electrical components are in the gas/electrical compartment on the left side on the outside of the fireplace. This compartment houses the gas valve, a single-gang outlet, and the electrical receiver. Correctly size and route the gas supply line from the supply regulator to the top left opening of this compartment, as per the requirements outlined in the latest edition of the National Fuel Gas Code, NFPA 54 (USA) or CAN/CSA-B1491 (Canada). See exact location of Gas and Electrical knockouts, see "General Product Information" section.

A gas shut-off valve and a 12" gas flex connector are provided with every fireplace. The location of the gas shut-off valve is dependent on local codes and requirements. Check with your authority having jurisdiction for more information.

It is recommended that extra gas line be installed within the masonry to allow for the removal of the insert for future servicing needs. Internal built in access is not always the preferred method of choice when servicing the fireplace, your authorized Ortal Technician will determine the best course of action when servicing the fireplace.

 **WARNING:** The main gas valve must be installed to allow complete disconnection of the fireplace from the gas supply piping system for servicing purposes.

## Access Panel

It is unnecessary to provide an access panel for the Wilderness Traditional Insert Series. Components are accessible to service through:

- Built-in access panel on the inner left side of the fireplace; remove glass, media, and burner tray to access.
- Exterior access panel on the outer left side of the fireplace; detach the slide plate, slide the fireplace out of the existing masonry fireplace to access.

See "Service Door for Electronics and Gas" section for instructions on how to service the insert from both locations.

## Gas Conversion

Gas conversion (NG to LP or LP to NG) of the Wilderness Traditional Insert series fireplaces can be done in the field. Gas conversion must only be performed by a technician who has specific authorization by Ortal to change these components. The conversion kit must be supplied by Ortal. Using parts from other manufacturers or having an unauthorized party perform the conversion will void your fireplace's warranty. Conversion instructions are supplied with the conversion kit. Wilderness Traditional Inserts also require you to convert the log set depending on gas type.



A duplex receptacle with two outlets (not included) must be installed in the location where the gas and electrical components will be placed, which must be to the side or back of the fireplace within 36 inches of the pilot (see diagram in "Routing the Gas Line" section). Electrical work should be performed by a qualified licensed electrician, according to local code.





If the batteries are used instead of the AC Adapter, the fireplace can operate in the event of a power outage to the building. Batteries must be replaced annually. Fireplaces with Wi-Fi or lights can still be battery-operated, but the Wi-Fi and light will not function.



## Pairing the Remote and Receiver

To set up the remote-control device to operate the fireplace, follow the following guidelines to pair the remote and receiver unit on the same radio frequency.

1. Press and hold the receiver's reset button until you hear two beeps. The first beep is short, and the second beep is long. After the second beep, release the reset button.
2. Within the subsequent 20 seconds, press the following button depending on the mode of operation:
  - **10-Button Handset:** Press the  button until you see the word "CONN" and a number counting up from 1 to 8 appear on the handset display. This confirms that the synchronization and data exchange are in process.
  - **Puck Handset:** Press and hold the – button approximately 4 seconds.
  - **Wall Switch:** Use the 10-button handset to synch with the receiver. Once the remote and receiver are paired, the wall switch will function normally.
  - **MyFire App:** Use the 10-button handset to synch with the receiver. Once the remote and receiver are paired, the App will function normally.
3. You will hear two short beeps confirming the connection.




### NOTES:

- If you hear one long beep, this indicates the connection has failed or the wiring is incorrect.
- The connection between remote and receiver only needs to be made once and is not required after changing the batteries in the remote.


## Contacts Options/Operation

**Ignition:** Close contacts 0 (orange) and 2 (brown) simultaneously for 1 second. The fireplace automatically goes to high after ignition.

**Up Flame:** Close contacts 0 (orange) and 1 (red) simultaneously. The contact needs to be closed for 12 seconds to turn the motor from end-stop to end-stop.

**Down Flame:** Close contacts 0 (orange) and 3 (black) simultaneously. The contact needs to be closed for 12 seconds to turn the motor from end-stop to end-stop.

**Off:** Close contacts 0 (orange) and 2 (brown) simultaneously for 1 second.

**Mode of Operation:** The external source provides ON and OFF operation only. The Timer/Thermostat handset provides all other functions.






1. **Firelogs are fragile.** Handle them gently to prevent damage to their paint or to the fireplace.
2. **Arrange firelogs as shown in the section below.** Do not arrange them in any other way. If firelogs are not installed per installation instructions, flame impingement and improper combustion may occur and result in soot and/or excessive production of carbon monoxide (CO). Carbon monoxide is a toxic, colorless, and odorless gas.
3. **Do not install the firelog media until** fireplace installation is complete, the gas line is connected and tested for leaks, and initial burner operation has been inspected and approved.
4. **Keep 1 inch around the pilot (behind pilot hood) completely clear of any media or debris.** Contact between the nickel strands and the spark plug cable may lead to failure operating the fireplace.
5. **Do not cover the main burner holes** (marked in the image below) unless otherwise stated in this manual. Blocking the holes can cause a gas release that could cause an explosion in the fireplace.



6. Placing the log onto the log base/tube:  
**Step 1:** Grasp the log at both ends as shown in the picture.



**Step 2:** Insert the tube coming out of the log into its base while making gentle rotational movements back and forth around its axis for easy insertion/removal. See figure below.







Adjust the log base as necessary, retightening the screw to keep the log base in the desired position.

# Log Base Aeration

## STEP 1

Loosen the log base aeration screw with a 2.5mm Allen Key.



## STEP 2

To adjust the aeration level, rotate the air shutter per specifications listed in the table below. Tighten the screw to keep the shutter in the desired position.



## →Panel Option Installation Guidelines

Internal panels are required to complete installation of the Wilderness Traditional Insert.

### Brick and Blackridge Panels

Layout the three panels, ensuring that any grout lines align. Horizontal and Herringbone options back panel orientation matters for proper alignment. Mounting brackets for the left and right-side panels ship in place.



Part Identification

#### **STEP 1**

Locate the support brackets from the top of the inner firebox. Using a Phillips head screwdriver, remove both brackets by removing the two bolts holding them in place.

#### **STEP 2**

Place the back piece (#1) of refractory into the insert. It will sit on a small lip on the back of the inner firebox.

#### **STEP 3**


While supporting the back piece with one hand, slide the left side (#2) into place.


Reinstall the left side bracket using the two bolts removed in step 1.


Repeat steps 3-4 to install the right side (#3).

## →Black Reflective Panels

Reflective Panels require supplied black panels to be installed behind them. Mounting brackets for the left and right-side panels ship in place.

#### **STEP 1**

Locate the support brackets from the top of the inner firebox. Using a Phillips head screwdriver, remove both brackets by removing the two bolts holding them in place.

#### **STEP 2**

Place the back black panel piece into the insert. It will sit on a small lip on the back of the inner firebox.

#### **STEP 3**

While supporting the back piece with one hand, slide the left side panel into place.

#### **STEP 4**

Slide the right-side panel into place.

#### **STEP 5**

Place the back reflective panel into the insert. It will sit on a small lip on the back of the inner firebox.

### **STEP 6**


While supporting the back piece with one hand, slide the left side reflective panel into place.

### **STEP 7**


Reinstall the left side bracket using the two bolts removed in step 1.

Repeat steps 6-7 to install the right-side reflective panel.



**Bolt Placement for Mounting Brackets**




**Installation of Mounting Brackets**

## **Service**

### **Front Frame**


A front frame is required to complete installation of the Wilderness Traditional Insert. To remove the front frame, grasp the frame from the sides and lift upward and pull out like shown in the illustrations below.



To reinstall the front frame, align the four brackets (two on each side) of the frame with the two top and two bottom bolts, lift up slightly and push decorative front toward fireplace until brackets and bolts are engaged. When properly installed there should be 1/2" gap between the front frame and surround.

## Surround


A surround is required to complete installation of the Wilderness Traditional Insert. To remove the surround, locate the six bolts that attach the surround to the insert. Using a Phillips head screwdriver, remove the bolts while supporting the surround as you detach the surround.




To reinstall the surround, align the six bolt holes on the surround with the six threaded rivnuts on the insert. Start threading each bolt before tightening them all for easier installation.

## Glass Assembly


Before removing the glass assembly locate the glass tool, located in the bottom right-hand corner of the insert resting on the side of the outer wrap, with magnets.



With one hand supporting the glass assembly, locate the two keyholes located at the top of the firebox. Engage the end of the glass tool with the keyholes one at a time.




Pull out and then lift to release the keyhole latches. These keyholes are spring loaded and will retract into place once released.




Tilt the glass assembly forward, and then lift up and out.

To reinstall the glass assembly, locate the bracket at the bottom center of the unit. There are two notches utilized for securing the bottom of the glass frame to the unit. Align the two tabs on the glass assembly, the left and right-side notches should just line up with the slots circled in the diagram below. Tilt the glass assembly toward the insert and use the glass tool to engage the spring-loaded keyholes back onto the top of the glass frame.



## Front Profile

At the bottom of the unit there is a front profile piece which acts as a vanity panel. For proper installation, verify the side with the notch circled below is facing the unit. Part is to be installed with the glass assembly installed but prior to the front frame installation.




## Service Door for Electronics and Gas

There are two ways to access the electrical and gas components; internally through the left side of the inner firebox or externally on the left side of the outer wrap of the firebox.


### Internal Access

Remove the front frame, glass assembly, logs, media, media tray and any refractory installed. The access panel is located on the left side of the inner firebox and secured by nine bolts. Using a Phillips head screwdriver, remove these bolts. Lift up and remove the access panel, revealing the electrical and gas components.




### External Access

Disconnect the slide plate from the insert and remove the insert from the masonry, see "Slide Plate" instructions in the next section on how the slide plate operates. The access panel is located on the left side of the outer firebox wrap and secured by eight bolts. Using a Phillips head screwdriver, remove these bolts. Lift up and remove the access panel, revealing the electrical and gas components. Keep in consideration that some components are attached to the access panel, therefore range of mobility is limited.





## Slide Plate



When connecting the vent liners or needing to access the insert from the external access panel follow these instructions. Locate the slide plate tool, stored on top of the insert, resting on a cut out for positive placement.



Using a Phillips head screwdriver, remove the two bolts attaching the slide plate. Place the end of the slide plate tool into the cut out on the slide plate.



Proceed turning the slide plate tool clockwise to prevent the tool from losing its grip. Push to disengage the slide plate from the top of insert.



**NOTE:** Follow these steps in reverse for instructions when attaching the vent liners and for assistance on sliding the insert into the masonry.

# Operation

**WARNING** – Read these instructions carefully before lighting the fireplace.

Four operation options are available for use with the fireplace:


- 10-Button Remote Control Handset (default option, always included with the fireplace)
- Puck Handset (optional accessory)
- Wall Switch (optional accessory)
- MyFire Application (optional accessory)

**IMPORTANT:** The 10-Button remote control handset is always included with the fireplace regardless of which operation option is chosen. **DO NOT DISCARD.** The 10-Button remote must be always kept within 26 feet of the fireplace.

**NOTES:**

- Wiring of valve and receiver must be completed before starting ignition. Failure to do so could damage the electronics.
- If operating the fireplace without an AC adapter, battery replacement is recommended at the beginning of each heating season.
- Fireplaces with double glass, power vent, and/or interior lighting features must operate using the AC Adapter and therefore will not operate during a power failure.
- Only the Meritk Maxitrol AC Adapter is permitted for use with the fireplace. Use of other adapter brands can render the system inoperable. The handsets, receivers, wall switches are not interchangeable with other electronics.
- Batteries must be kept within their recommended temperature limits (32°F to 131°F).



## Turning the Fireplace On



1. Press the  button until you hear continuous beeping, and a blinking series of lines confirms the start sequence has begun; release buttons.
2. Main gas flows once pilot ignition is confirmed.
3. The system automatically goes into Manual Mode after main burner ignition.

 **NOTE:** When pilot ignition is confirmed, motor turns automatically to maximum flame height.

 **NOTE:** If the Timer function has been set and the fireplace is manually turned on, the Timer function will need to be reset.



**IMPORTANT:** For safety/communication purposes, the 10-button handset must be located within 26 feet of the receiver.

## MyFire Wi-Fi Box

The MyFire Wi-Fi router box provides the Wi-Fi connection that allows the MyFire App to operate the fireplace. This part is included with the optional Wi-Fi kit. A Wi-Fi kit does not automatically come with the fireplace and must be ordered.

# Fireplace Maintenance

## General Maintenance

All servicing, maintenance, interior cleaning and handling of the fireplace, parts and glass must be performed by an authorized Ortal dealer service technician only.

### Servicing

- Turn off the gas and electricity **BEFORE** servicing the fireplace.
- It is recommended that a routine inspection is performed at the beginning of each heating season.
- When removing glass from multisided fireplaces, only one side of glass can be removed at a time. Glass must be re-installed before removing glass from a different side.

### Metallic Noise

- Noise is caused by metal expanding and contracting as it heats up and cools down, like noise produced from a furnace. The noise does not affect the operation or longevity of the fireplace.
- These minor expansion, contractions or movement of parts causing noise are normal. Complaints related to these noises are not covered by the warranty.

### Burner and Vent Inspections

- Periodic checks should be made of the burner for correct position and condition. Visually check the flame of the burner, making sure that the flames are steady.
- The vent system must be inspected before use. Annual inspection must be scheduled to ensure the flow of combustion and ventilation air.

### Submerged Parts

- Do not use the fireplace if any part has been under water, or if you suspect that it may have been under water. The Ortal dealer service technician must inspect and, if necessary, replace any parts of the control system and any gas controls which have been underwater.

### Handling the Glass

The inner glass panel is 5mm ceramic glass. Ceramic glass must be provided by Ortal.

- **NEVER** operate the fireplace without the glass properly secured in place.

### Cleaning the Fireplace

- Only an Ortal dealer service technician can open the fireplace to clean interior surfaces.
- **ALWAYS** turn off the gas valve before cleaning.
- Do **NOT** clean when hot. Make sure the fireplace has had time to cool prior to cleaning any surface or component, interior or exterior.
- Keep the fireplace clean by brushing and/or vacuuming at least once a year. This can only be performed by an Ortal dealer service technician.
- Clean the glass when it starts to look cloudy. Use a damp cloth for cleaning the fireplace and the door.
- Verify correct operation after servicing.

### Maintenance Frequency and Equipment Checklist

- Under normal circumstances, the factory recommendation is to have the fireplace serviced at least once a year. Fireplaces meeting the following conditions should have more frequent service:
  - Fireplaces installed in commercial/public spaces should be serviced every 3 months.
  - Fireplaces installed in climates near the ocean or in other settings where corrosion buildup is more likely should be serviced every 6 months.
- Thermocouple Maintenance:
  - The thermocouple should be replaced annually or as needed in all commercial installations, and in any residential fireplace where the fireplace is operated for an average of 10 hours or more per day.
  - For all other installations, the thermocouple should be replaced every three years or as needed.
