About the Foundations Fees Schedule

This document provides a consolidated view of all amounts deducted from donations made to the charitable foundations that Benevity works with ("Foundations"). Please note that all amounts and fees indicated in this document may be updated periodically. If a Benevity client's agreement rates differ from the rates indicated in this document, the rates in the master agreement will supersede the ones noted in this document.

Manual Check Fee

When a recipient Cause has not enabled an electronic method for payment, the funds it receives are subject to a manual processing fee. The fee applies only after a Cause has received two checks, in order to give it time to set up an electronic donation payment option.

Note: Checks will not typically be distributed to a Cause outside of the U.S. or Canada; such Cause outside of the U.S. or Canada will typically need to sign up for electronic payment via the Benevity Causes Portal in order to receive Donation Funds.

Cause Support Fee

The Foundations deduct a portion from donations to cover administrative and operating expenses to conduct their charitable operations.

Note: The Cause Support Fee Caps do not apply to matching transactions or gift of securities donations. The Cause Support Fee Cap also does not apply to Benevity Grants or Versaic Grants. This maximum deduction from each donation fee change does not apply to existing clients as of October 1, 2023.

^{**} The maximum deduction from each donation in the local currency is CAD \$500, EUR €500, GBP £500, NZD \$500, AUD \$500, SGD \$500, ILS №1,500, PLN zł1,600, SEK 4,500kr, ZAR \$7,500, INR R35,000, JPY ¥60,000



Merchant Fees

When a donation is made using credit card, Apple Pay or PayPal, a payment processing fee is deducted from the donation to cover "merchant account" or "interchange" fees that are charged by third-party payment processors to the Foundations.

Note: All credit and debit card payment processing fees also apply to Apple Pay.

Foreign Exchange Transaction (FX) Fees

The foreign exchange (FX) occurs after all the funds destined to a Cause are aggregated for disbursement. This means that the currency exchange happens at the time of disbursement.

Note: An FX fee of 1.50% on the FX rate is applicable to the following Cause countries: Canada, United States, United Kingdom, India, Australia, Germany, Ireland, France, Italy, Spain, Switzerland, Poland, Ukraine, Taiwan, Israel, Netherlands, Turkey, Brazil, Singapore and Japan. Conversely, an FX fee of 2.00% - 2.40% shall apply to all remaining countries. Due to economic conditions and/or currency liquidity, tertiary currencies may have higher FX fees.
